## **PROTECTION OF PERSONAL INFORMATION ACT (POPI) NOTIFICATION**

Dear Valued customer/client, supplier, contractor, third party

As the South African Protection of Personal Information Act (POPI) will officially be enforced on 31 October 2023, NET-EX (PTY) LTD herewith notifies all customers/client, suppliers, contractors and third parties of the compliance of NET-EX (PTY) LTD hereto. The POPI Act intends to fight cyber-crime primarily in association with Governments internationally.

The POPI Act also intends to promote the right to privacy while at the same time, protecting the flow of information and the right of access to information.

The POPI Act establishes the rights and duties of organisations to collect and use personal data for business balanced against the right of individuals to have their personal details respected.

This notification sets out how personal information will be collected, used and protected by NET-EX (PTY) LTD as required by the POPI Act.

The personal information that NET-EX (PTY) LTD might require will adhere to the requirements as set out in the POPI Act of 2013.

Customers/clients, suppliers, contractors and third parties acknowledge and hold the right to request a list of the names and addresses of a potential recipient/s of the information and to review and correct the information.

Customers/clients, suppliers, contractors and third parties acknowledge that the collection, processing and transfer of the information is important to enforce the contractual relationship with NET-EX (PTY) LTD.

All personal information will be held securely. Whenever NET-EX (PTY) LTD commissions other organisations to provide support services, NET-EX (PTY) LTD will conclude a written agreement with the operator to establish and maintain confidentiality and security measures to ensure the safety of personal information.
